Brief Rules and regulations for participation in fair

1. Stall Booking:
Booking of stall is for display/retail sale in Punjab Pavilion Pragati Maidan, New Delhi during IITF-2016 from 14-11-16 to 27-11-16.
2. Allotment of space to the participants :
Stalls will be allotted on the suitability of the products and subject to fulfillment of terms & conditions and receipt of full payment. Submission of application / payment for booking of stall does not automatically confer a right for allotment of space. Allotment of stalls will rest with Administrator, Punjab Pavilion.
3. Facilitation Charges:
Participants will have to pay facilitation charges @ ₹80,000/- per stall + service tax as applicable along with the application.
4. Refund of amount paid:
Refund of amount paid will be considered in case of non-availability of space, rejection of application or in the event of cancellation of participation due to unforeseen circumstances.
5. Expenses:
All expenses of the exhibition like preparation of catalogue, freight and cartage of exhibits are to be borne by the participant.
6. General :
 - i) Only Products from Punjab State will be allowed to be displayed / sold at Punjab Pavilion.
 - ii) In the event of postponement/abandonment / cancellation of the Fair / Exhibition, or in case of exhibits not being displayed due to any reason beyond the control of the Punjab Pavilion/PSIEC, it shall not be liable for any loss or liability.
 - iii) The stall allotted to the participant is to be exclusively used by them for display/sale of their products. Sub-letting is not permissible. Violation of this clause may lead to cancellation of stall allotted/forfeiting of amount deposited and they will be debarred from future participation.
 - iv) Participant will be responsible for the payment of applicable taxes. They have to produce certificate in this regard before vacating the stalls failing which material will not be allowed to be removed after the close of the fair.
 - v) Any dispute or differences arising out of these terms and conditions of participation shall be referred to the Managing Director, PSIEC whose decision of award shall be final and binding.
 - vi) Any terms & conditions can be changed/alterd at the discretion of Management at any time without assigning any reason thereon.
 - vii) Stalls at concessional rate will be allotted to the following :-
Craftsperson who has been awarded "National award / Certificate of Merit" by the office of Development Commissioner (Handicrafts), New Delhi and persons/firms who have been awarded 'Punjab State award / Certificate of Merit / Consolation' by Department of Industries & Commerce, Punjab will be allowed 75% concession
 - Viii) The terms and conditions of participation shall be subject to the jurisdiction of courts in the UT of Chandigarh.
